



## RULES FOR VISITING RESIDENTS (Post Covid- 19)

### Visitor Rules:

- All visitors are required to abide by the Visitor Code of Conduct.
- Only pre-scheduled visits will be allowed. Visits are limited to one visit per resident every two weeks. Visitors are limited to a maximum of 3 visitors for outdoor visits or 2 visitors for indoor visits.
- All visitors are required to remain in their assigned visitation area.
- If arriving early, please remain in vehicle until your scheduled time.
- All visitors are required to wear a face mask which covers their mouth and nose to enter the facility. The Receptionist will give each visitor a hospital grade face mask that covers mouth and nose. Visitors must wear this hospital grade mask for the duration of their visit.
- All visitors are required to maintain 6-foot social distancing.
- All visitors and residents are required to use hand sanitizer before and after visit.
- Visitor may not bring food or gifts when visiting.
- Visitation areas are disinfected after each use.
- All visitors are required to adhere to allotted visitation times.
- All visitors are required to stay home if they are ill, have been told to quarantine due to possible COVID-19 exposure or have visited a county, state, or country currently under a travel advisory within the past 14 days.

### Visitor Code of Conduct:

The safety, security and conduct of Holy Family Senior Living (HFSL) employees, residents, contractors, vendors and visitors while on HFSL premises are of vital importance.
